The introduction of Fare Parity effective January 1, 2013 has a direct relationship to the City's strategic directions:

<u>Vibrant Neighbourhoods</u>: by improving mobility for users of the specialized (Handi-Van) service both into and out of the City.

<u>Excellence in Government</u>: by operating an effective and efficient service focused on the needs of residents and employers and contributing to environmental sustainability through greater use of public transit recognizing an aging demographic.

### **Background:**

### **AODA Integrated Accessibility Standards (Regulation 191/11)**

The Accessibility for Ontarians with Disabilities Act (AODA) received Royal Assent on June 13, 2005, and is now law. This legislation has a mandate to achieve full accessibility with regard to goods, service delivery, facilities, accommodation, employment, buildings, structures and premises for Ontarians with disabilities by 2025.

The Integrated Accessibility Standards (Regulation 191/11 under the AODA) combines mandatory sector specific standards, including Information and Communication, Employment, and Transportation into one (1) comprehensive legislation. These mandatory accessibility standards set out the measures, policies, practices and other steps needed to remove and prevent barriers for persons with disabilities. They also address the full range of disabilities including physical, sensory, mental health, developmental and learning.

This regulation came into effect on July 1, 2011 and contains close to 200 compliance items required between July 2011 and January 2021. The delivery of Burlington Transit services must meet the legislated accessibility requirements within established timelines as outlined by the Province of Ontario.

Report TR-07-12 addresses the requirement to implement fare parity by January 1, 2013.

### **Discussion:**

The recommendations provided in TR-07-12 are related to the compliance of the following subsections of Section 66; Fare Parity of the new AODA legislation:

**Sub-section (3) states** - "where a transportation service provides both conventional transportation services and specialized transportation services, the transportation service provider shall ensure that there is fare parity between conventional transportation services and specialized transportation services".

**Sub-section (5) states** - "where a transportation services provider provides both conventional transportation services and specialized transportation services, the transportation service provider shall ensure that the same fare structure is applied to conventional transportation services and specialized transportation services".

**Sub-section (6) states** - "where a transportation services provider provides both conventional transportation services and specialized transportation services, the transportation service provider shall ensure that the same fare payment options are available for all transportation services, but alternative options shall be made available to persons with disabilities who cannot because of their disability use a fare payment option".

Fare parity includes all fare options being offered on both conventional bus and specialized (Handi-Van) services. Sole providers<sup>1</sup> are required to ensure that all fare media options for conventional service in a jurisdiction are to be made available on the specialized service by January 1, 2013.

This means that in order to comply with the prescribed legislation by the specified date of January 1, 2013, the following amendments to the Transit By-law are required:

### Fare Structure and Pricing:

- Conventional bus fare structure and pricing will be applied to specialized service including the concession categories of adult, student, senior, and child.
- Current Handi-Van paper tickets will be eliminated.
- The full conventional transit fare media product offering will be implemented for Handi-Van clients:
  - reducing the current Handi-Van ticket price of \$2.75/ticket to the current Adult conventional ticket rate of \$2.50/ticket; and,
  - acceptance of regular paper tickets and monthly passes (Adult, Student, Senior, and Child) on the Handi-Van service, provided the passenger is a registered user of the Handi-Van service; and,
  - acceptance of PRESTO on the Handi-Van service, provided the passenger is a registered user of the Handi-Van service. This will enable Handi-Van clients to take advantage of the many benefits PRESTO offers customers including equivalent pricing for single fare e-purse payment usage to paper ticket pricing, card registration.

<sup>&</sup>lt;sup>1</sup> Under the AODA legislation, a "sole provider" is a service provider that provides both conventional and specialized transit services within the same jurisdiction.

### Transfer Policy:

- The current two-hour open transfer policy in place in the conventional system will be applied to the Handi-Van specialized service.
- Passengers may begin to transfer between municipal service providers (i.e. registered Burlington Handi-Van clients can transfer to Oakville's Care-A-Van service at no extra charge provided that a) the transfer is occurring within the two-hour time limit, b) the passenger is also registered with Oakville's Care-A-Van service, and c) the passenger books the appropriate appointments in advance with each service).
- Passengers may transfer from specialized to conventional service at no extra charge, and vice-versa, provided they are registered on the specialized service and within the two-hour transfer limit.
- Passengers may transfer from Oakville's Care-A-Van or Hamilton's DARTS services onto a Burlington Handi-Van for no additional charge provided the transfer occurs within the current two-hour open transfer time limit and the passenger is a registered Handi-Van user. Specialized transit passengers must continue to book their trips through the respective agencies.

### Free Fare for Persons who are Blind:

- Free fares for persons who are blind have been provided for in the conventional Transit By-law since 1976, but not honoured on the specialized (Handi-Van) service.
- In order for passengers with a visual disability to ride for free, he/she must present a valid CNIB card to the operator upon boarding the conventional bus.
- These boardings are tracked for statistical reporting purposes and represent approximately 7,000 trips per year.
- The purpose of introducing fare parity is to ensure uniformity of application of the fare policies across conventional and specialized services. It is therefore recommended that the provision for "free" fares for persons who are blind be eliminated to ensure consistency within the fare structure related to the introduction of fare parity.

### Reduced (Special Rate) Fare:

- A special rate (child fare equivalent) has been offered to employees of ARC Industries (Community Living Burlington) and attendees of Halton District School Board Special Learning Programs since 1976, with original authority under By-law 76-1985, which was subsequently repealed in 2008 by the new Transit By-law 97-2008.
- These boardings are tracked for statistical reporting purposes and represent approximately 2,600 trips per year.
- Presently Burlington Transit is the only transit authority in Ontario that provides a "special rate" reduced fare to a specific special interest group(s).
- The purpose of introducing fare parity is to ensure uniformity of application of the fare policies across conventional and specialized services. It is therefore

recommended that the provision for "special rate" reduced fares be eliminated to ensure consistency within the fare structure related to the introduction of fare parity.

### **Financial Matters:**

The implementation of fare parity will have a negative impact on current fare revenues for Handi-Van Service based on the following factors:

- Reduction in ticket prices from \$2.75 to \$2.50 per ticket
- Introduction of monthly paper pass products for Handi-Van clients
- Introduction of PRESTO loyalty for Handi-Van users (i.e. for an Adult, after 36 full fare rides in one calendar month, the remaining rides are free for that calendar month)
- Introduction of timed open transfer policy of two hours internally (i.e. conventional BT bus to Handi-Van and vice-versa) and externally (i.e. Oakville Care-A-Van to Burlington Handi-Van and vice-versa) to be consistent with conventional services

Given Burlington Handi-Van's ridership demographic, and factoring Oakville's experience with fare parity over the past year, the associated fare parity measures contained in this report will have an estimated<sup>2</sup> annual Handi-Van fare revenue impact of \$40,600 reduction in 2013.

The 2013 Proposed Current Budget for the Transit Department has been prepared to reflect a fare revenue reduction in base budget, from \$133,000 per year (2012 approved plan) to \$92,400 (proposed 2013 base budget).

The above loss in fare revenues would be offset by a slight increase in additional estimated conventional fare revenues of \$21,400 based on the elimination of free fares for persons who are blind<sup>3</sup> and the elimination of the "special rate".<sup>4</sup>

### **Communication Matters:**

Upon Council approval of the recommendations contained in TR-07-12, staff will prepare and execute a Communications Plan to inform the public of the proposed changes prior to January 1, 2013.

<sup>&</sup>lt;sup>2</sup> Estimated loss in fare revenues based on conventional transfer rate of 32.8% and estimated cash to ticket ratio of 25:75.

The Transit By-law currently permits passengers presenting a valid CNIB card to ride for free (applies to conventional service only). Based on the average fare of \$2.22 and approximately 7,083 passengers per vear.

<sup>&</sup>lt;sup>4</sup> The Transit By-law currently provides a special rate (equivalent to a Child fare) to employees of ARC Industries (Community Living Burlington) and attendees of Halton District School Board Special Learning Programs under authority of By-law 76-1985 as amended (applies to conventional service only). Based on the average fare of \$2.22 and approximately 2,600 passengers per year.

Messaging will be prepared using various means including:

- Newspaper advertisements
- City's website (splash page) and Burlington Transit's website
- Posters on board the conventional bus and specialized (Handi-Van) services
- Posters at the Downtown Transit Terminal, Transit Headquarters, City Hall, P&R Community Centres and Libraries
- Posters at Authorized Third Party Ticket Sales Agents
- Direct Notification to CNIB, Burlington Association for Community Living, and HDSB, HCSB

### **Conclusion:**

The Burlington Transit specialized transit service (Handi-Van) fare structure must be revised to be consistent with that applied to conventional services per AODA integrated transportation legislation. This means that all fare products and pricing currently offered on the conventional bus system must also be offered on the specialized (Handi-Van) system by the required compliance date of January 1, 2013.

# Appendix "A" THE CORPORATION OF THE CITY OF BURLINGTON BY-LAW NUMBER XX-2012

### A By-law To Regulate Burlington Transit

File: 770-01

**WHEREAS** Section 11 of the *Municipal Act*, 2001, as amended, authorizes The Corporation of the City of Burlington to enact by-laws respecting matters within the sphere of jurisdiction of municipal property, private property and highways;

# NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF BURLINGTON HEREBY ENACTS AS FOLLOWS:

1. Part I Definitions of By-law 97-2008, as amended, is hereby amended as follows:

#### **DELETE:**

"transfer" means a receipt obtained from an operator that permits the holder to travel on a transit vehicle during the time period indicated on the transfer, obtained from Burlington Transit, Hamilton Street Railway, Oakville Transit or any transit authority specified by Burlington Transit;

### ADD:

"transfer" means a receipt obtained from an operator that permits the holder to make unlimited travel on a conventional or specialized (Handi-Van) transit vehicle within 120 minutes (2-hours) from the time of original issuance indicated on the transfer. Reciprocal transfer agreements may be established to permit the acceptance of transfers at par to/from other transit authorities, provided the transfer is presented within 120 minutes (2-hours) from the time of issuance. Other transit authorities may include, but are not limited to, the Hamilton Street Railway Company and/or DARTS, Oakville Transit and/or Care-A-Van.

2. Schedule "A" of By-law 97-2008, as amended by By-law 61-2012 is hereby repealed, and Schedule "A" *including noted amendments* attached to this by-law are substituted therefore.

THAT in all other respects, By-law 97-2008, as amended, is hereby confirmed.
